For general transportation industry requirements, we offer the cardlock method of refueling at any of our more than 300 cardlock locations across Western Canada. Cards can be ordered to access all sites (national) or may be restricted to one province (provincial).

In addition to cardlocks, we provide a commercial fleet card program, valid for fuel and other related automotive services at any of our more than 600 CO-OP™ or independent TEMPO® service stations and gas bars. Commercial fleet cards can be provided with or without product restrictions.

Choose from our selection of bulk deliveries direct from terminals or agent delivered products, depending on your needs, location and storage capacity.

Our fuel supply is backed by the Co-op Refinery Complex (CRC), a wholly-owned subsidiary of FCL. The CRC was founded in Regina in 1935. It was the world's first co-operatively owned petroleum refinery. In addition to refining sweet crude oil, CRC upgrades Western Canadian heavy crude oil into high quality light sweet crude oil. The CRC's total capacity is 100,000 barrels per day. A project to expand the CRC's crude processing has been completed and became operational in 2013. The expanded refinery is expected to achieve a 145,000 barrel per day capacity as the production matures. The CRC has evolved into one of the most productive value-added petroleum refining facilities in North America.

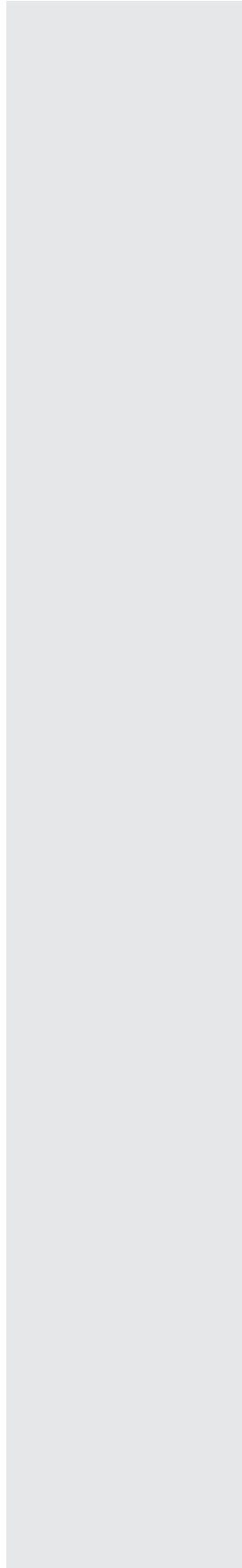

- Tell us what you do. Commercial petroleum accounts can be tailored to fit the needs of your business. Please note only businesses are eligible for a Federated Co-operatives Limited Commercial Petroleum account. For personal/consumer or small volume commercial accounts call your nearest region contact (see the column to the left) for further options.
- Provide bank and trade references. These references are essential for us to process your application. Trade suppliers are businesses with which you have already established credit. (Please note that fax numbers are required.) - Please sign, date and identify yourself clearly in order to make it easy for us to start the account application process.

We're excited to welcome you to our network. Please note, only complete applications will be processed. If you wish to include any additional information, please attach the proper documentation to your application.
